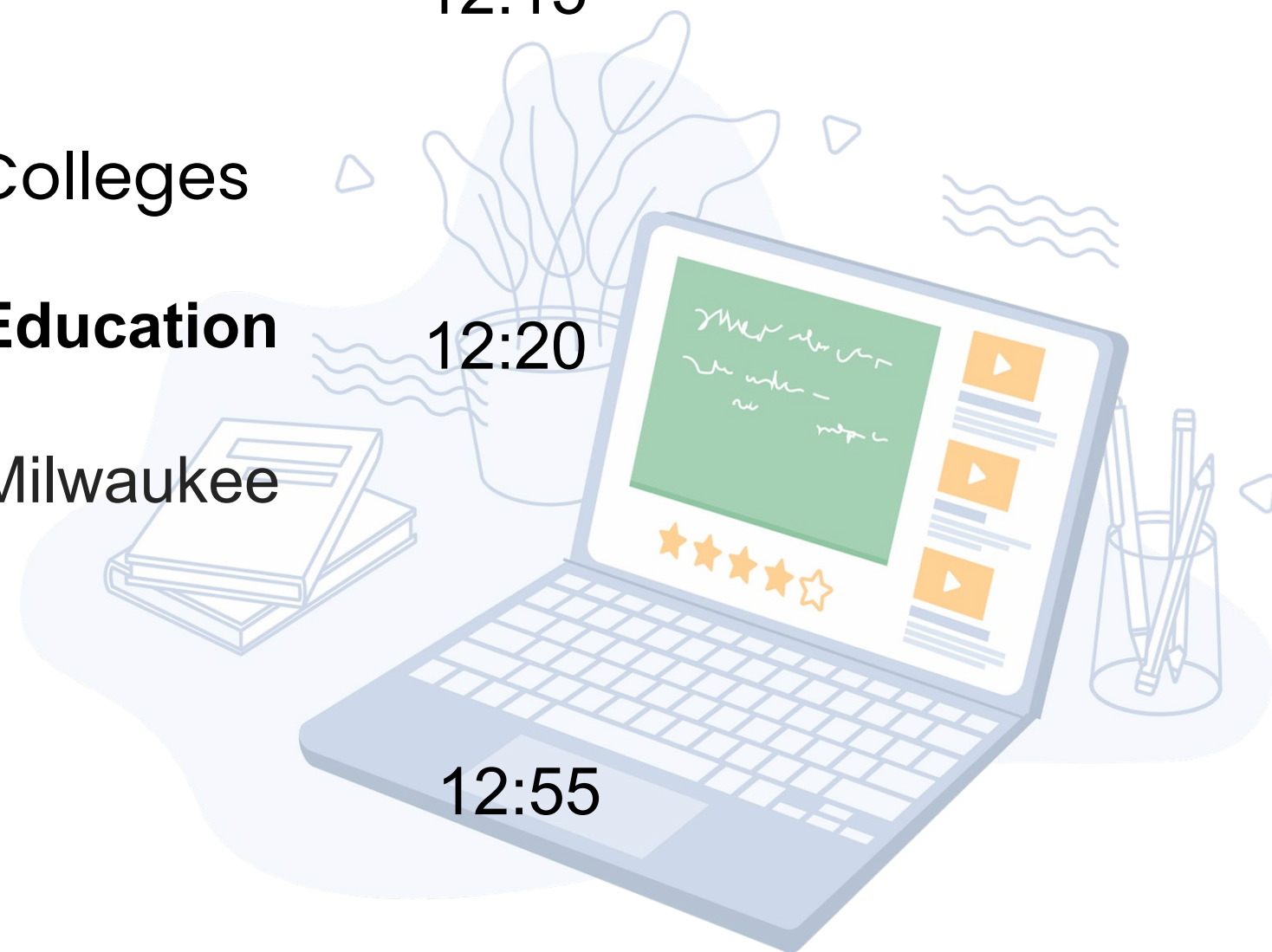

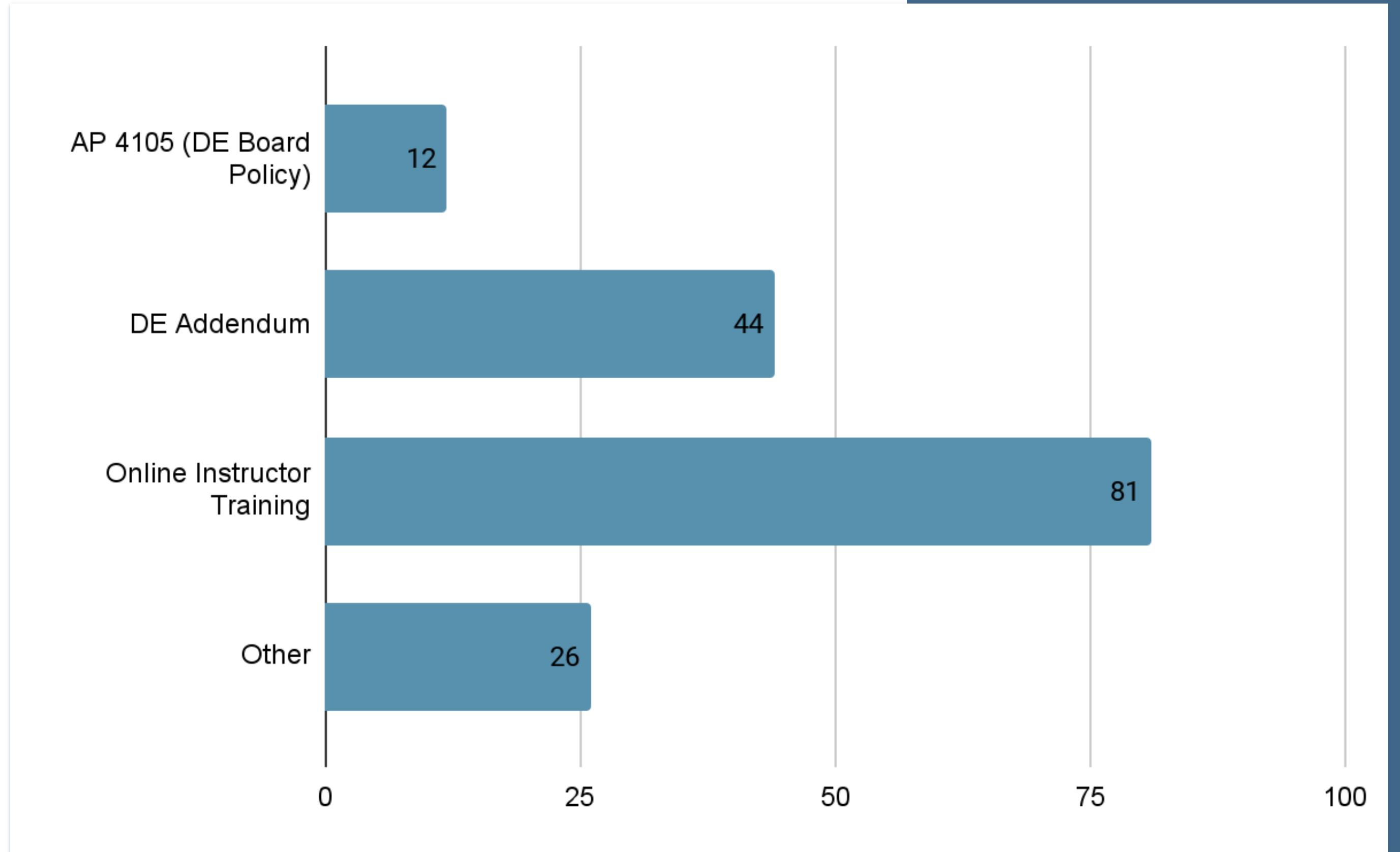

Introductions

- **Foundation for California Community Colleges** – Official nonprofit auxiliary of the California Community Colleges(CCC) Board of Governors and Chancellor’s Office. Part of the CCC System.
- **CollegeBuys** – A program designed to aggregate the buying power of the CCC and optimize acquisition of goods and services for the system.

What is STAC-STARTE?

- **STAC** (Systemwide Technology Access Collaborative) – technology resources identified on the system level, a collaboration between the CCC Chancellor’s Office, the California Virtual Campus initiative, and CollegeBuys.
- **STARTE** (Systemwide Technology Access Resource Tools for Education) – technology resources that are locally championed, wherein in a critical mass of colleges have expressed interest for a certain vendor supporting online teaching and learning.

Streamlining Procurement with STAC-STARTE



College departments collaborate and submit one form to CollegeBuys. A not-to-exceed quote will be sent.



CollegeBuys processes all orders and provides suppliers one order form on behalf the CCCs.



Aggregating CCCs’ orders results in a decrease in price and an increase in cost savings.



Upon negotiating further discounts with suppliers, CollegeBuys will send final pricing to colleges.



Suppliers will contact the designated campus contact for service.

STAC-STARTE Metrics

- **Key Objectives:**
 - To provide broader access to educational technology tools at an additional discounted price (Lower cost for our colleges)
 - To develop contract terms and conditions that support all levels of accessibility and inclusion (Ensure equity and parity in resource delivery)
- **Annual Metrics (Since 2021):**
 - Comprises **97** CCCs
 - Delivers **\$8M** in cost savings
